PLEASE READ CAREFULLY: Exhibition Contract

This agreement is between the Red Brick Council for the Arts (RBCA) and _____ (artist) for the 2012 Red Brick Biennial/Juried Art Exhibition. The artist attests that the submitted artwork is original, and that the art has been made within the last two years. The artist also certifies that the art is soundly constructed, has no breakable or easily damaged parts, will not require maintenance, and will not cause safety or liability issues. The artist will be responsible for the integrity of the art. Any work delivered which is not ready to hang will not be accepted. The artist agrees that the RBCA is not patrolled nor monitored by a security system. The artist releases, indemnifies, and holds the RBCA, its board and employees harmless from any claims, actions, liabilities, losses, and attorney fees relating to or arising from losses, damage or destruction of the artwork from any cause. The artist assumes all risk associated with exhibiting art work and for utilizing the Red Brick Center. If the RBCA or its members, employees or trustees are made parties in a lawsuit, arbitration, proceedings or mediation involving the exhibition of his/her art work or his/her use of the Center or the Park, or use by his/her visitors or guests the artist shall be responsible for all costs incurred, including attorney fees, by the RBCA or its members, employees or trustees in such lawsuit, arbitration proceedings, or mediation.
